



## Volunteer Position Posting - Board of Directors

The Alzheimer Society of Toronto ("AST") invites submissions from individuals who are interested in being considered for the position of Director on the volunteer Board of Directors.

Alzheimer Society of Toronto offers support, information, programs and education to people with dementia, their families and their caregivers, to increase public awareness of dementia, to promote research, and to advocate for services that respect the dignity of the individual.

Revenue is received through a variety of sources including corporate donations, foundation grants, planned giving and bequests, individual donations and additionally, government grants for specific program initiatives.

The Board of Directors is the governing body of the Alzheimer Society of Toronto. Its mandate is to guide the Society in determining its vision, mission, values and strategic plan as well as to ensure that the Society is setting and accomplishing its goals while acting in accordance with its code of conduct.

The key roles for the Board are the following:

1. Strategic vision and goal setting
2. Financial oversight and accountability
3. Selection, supervision, and evaluation of the Chief Executive Officer
4. Approval of the strategic plan, annual plan and monitoring its implementation
5. Management of the work of The Board
6. Oversight of culture of philanthropy
7. Protection and enhancement of the Alzheimer Society brand.
8. Oversight of AST's risk management strategy.

Directors serve for a maximum of three, three-year terms. Commitment:

- Attend approximately 6 Board meetings per year (September – June)
- Contribute as a member on a Board Sub-Committee
- Support fundraising activities (within own means) and attend AST events
- Be passionate about our mission
